**Note:** *Not in good standing* is defined as not having filed the Annual report for 2 years and 2 months past the anniversary date for Annual Report filing. Registries would not be able to issue a "Certificate of Good Standing"

- Not in good standing triggers the commencement of a dissolution process

- If a corporation has not filed an annual report for 2 years and 60 days the company is placed into the first dissolution stage (D1 status). D1 triggers a Notice of Commencement (for BC Corporations) or Notice of Cancellation (for Extra Provincial Companies) letter to be mailed to the registered office (BC Corporations) or attorney address (Extra Provincial Companies). The letter states Registries will commence dissolution/cancellation after 30 days from the date of the letter.

- Once the 30 days have passed from the date the D1 letter was mailed (plus a tolerance time of 6-8 weeks) the file is moved to the next Dissolution stage (D2 status). D2 triggers a notice of intent to dissolve/cancel to be published in the BC Gazette.

- The legislation allows for a company to be removed from the Register any time after 30 days from the date of publication. Practice is to remove it within 30-45 days from publication.
